FIRST AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR THE ESTATES OF BONBROOK MERGING WITH BONBROOK ON CONCORD NEIGHBORHOOD ASSOCIATION, INC. AND FIRST AMENDMENT AND RESTATEMENT TO THE DECLARATION OF PROTECTIVE COVENANTS FOR BONBROOK ON CONCORD

THIS FIRST AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR THE ESTATES OF BONBROOK MERGING WITH BONBROOK ON CONCORD NEIGHBORHOOD ASSOCIATION, INC. AND AMENDMENT AND RESTATEMENT TO THE DECLARATION OF PROTECTIVE COVENANTS FOR BONBROOK ON CONCORD (the "Agreement"), is made and entered this the 5th day of ADril, 2005 2005, by BONBROOK HOMEOWNERS' ASSOCIATION, INC., a Tennessee not-for-profit corporation ("Bonbrook"), BONBROOK ON CONCORD NEIGHBORHOOD ASSOCIATION, INC., a Tennessee not-for-profit corporation ("Bonbrook on Concord"), CONCORD DEVELOPMENT, LLC, a Tennessee limited liability company, ("Declarant for Bonbrook on Concord") and JOSEPH C. FERRERAS and wife ANA MARIA FERRERAS, LANCEWORTH A. SCHULTERS and wife, SHERRICE N. SCHULTERS, DAVID A. REWERS and wife, JANICE L. REWERS, JAMES A. EVANS and wife, @REBECCA A. EVANS, CURTIS STEVENS and wife, JULIANE STEVENS, CHARLES W. STENGEL, JR. and wife VIRGINIA W. STENGEL JACEK M. SOBCZAK and wife, GRAZYNA SOBCZAK, DANIEL C. LIEBLER and wife, KAREN E. HERNANDEZ and JOHN WEILAND HOMES AND NEIGHBORHOODS, INC., a Georgia corporation, (hereinafter collectively referred to as "BONBROOK ON CONCORD OWNERS").

WHEREAS, the parties to this Agreement desire to merge Bonbrook with Bonbrook on Concord, and in furtherance of that desire, the parties find it necessary to amend the Declarations of Covenants, Conditions and Restrictions for the Estates of Bonbrook, of record in Book 1608, page 854, Register's Office of Williamson County, Tennessee ("Master CC&R's") to include the additional property, and further desire to amend and restate the Declaration of Protective Covenants for Bonbrook of Concord, of record in Book 2586, 659, Register's Office for Williamson County, Tennessee, and further to merge Bonbrook and Bonbrook on Concord into one not-for-profit corporation, being Bonbrook; and

WHEREAS, in furtherance of this objective, Bonbrook desires to amend the Master CC&R's pursuant to Article XIV, Section 3, whereby the Master CC&R's may be amended by the affirmative vote of not less than seventy-five percent (75%) of lot owners, said vote having been taken and passed, as certified by the President and Secretary of Bonbrook; and

WHEREAS, Bonbrook on Concord desires to amend and restated their CC&R's and to fully incorporate and adopt the Master CC&R's as their Covenants, Conditions and Restrictions, and further, to execute such articles of merger as are necessary with the Tennessee Secretary of State to merge Bonbrook on Concord into and with Bonbrook; and

WHEREAS, the parties have so voted to amend the Master CC&R's and CC&R's as follows.

NOW THEREFORE, the parties agree as follows:

- 1. The Master CC&R's shall be amended, by this instrument, to reflect the merger with, and inclusion of, the common area and members of Bonbrook on Concord, including all rights and responsibilities thereof, and all of the Property subjected to the Declaration of protective covenants for Bonbrook on Concord, of record in Book 2586, page 659, Register's Office for Williamson County, Tennessee, is hereby subjected to the Master CC&R's, so that such property shall hereafter be sold, transferred, used, conveyed, occupies and mortgaged or otherwise encumbered pursuant to the provisions of said Master CC&R's, all of which shall run with the title of such property and shall be binding upon all persons having any right, title or any interest in such property, their prospective heirs, legal representatives, successors, successor in title and assigns.
- 2. The CC&R's for Bonbrook on Concord shall be amended to reflect an abandonment of the existing CC&R's, the same shall be stricken from the records of record in the Register's Office for Williamson County, Tennessee, and the subsequent adoption of the Master CC&R's, and further, Bonbrook on Concord agrees to hereby be bound by the Master CC&R's and assume all responsibilities therefore.

- 3. All other terms and conditions of the Master CC&R's shall remain in full force and effect, and all terms and conditions of Bonbrook on Concord CC&R's shall be replaced in their entirety, by the Master CC&R's.
- 4. Bonbrook on Concord shall hereinafter be merged into and become part of Bonbrook and their corporate existence shall exist only as a portion of the merged entity.
